CCC'S CHAIR LETTER

I am very proud and happy with the results of 2021 and how we have positioned the Chile California Council for significant growth and enhanced financial resiliency in 2022 and beyond. Our amazing and dedicated staff, Board, and Councilors, continue to effectively draw upon a broad network of public and private individuals and institutions, to foster knowledge exchanges that benefit both Chile and California. I also want to acknowledge and thank the ongoing support from our partners, particularly the Ministry of Foreign Affairs of Chile, Marisla and Packard Foundations, among other friends from the private and public sectors of Chile and California. Our success is testament to our commitment to a better tomorrow, one that is more sustainable, equitable, and resilient in the midst of the ongoing challenges posed by Covid-19.

Some of the key successes of 2021 are:

- Hosted or participated in many webinars, presentations, and weekly newsletter that kept the CCC relevant as a conduit for knowledge exchanges between Chileans and Californians on climate change, coastal conservancy, and clean energy.
- Hosted four monthly meetings on the Clean Energy Transition. The meetings were attended by key individuals from the Ministries of Energy, Foreign Affairs, Science and Technology, and Environment of Chile, the California Energy Commission, various trade associations and private companies, consultants, academics, and NGOs in the clean energy space. A report on these meetings will be issued in early 2022. We plan to have a similar, follow-up effort in 2022.
- Continued support to the CCCx and their Public Trust Doctrine work that will result in significant improvement in the management of public lands and their protection. This work has been disseminated within Chile, where a Constitutional Assembly is considering including the conservation of nature into the new Constitution.
- Ideation of an Innovation Hub to support start-ups in the sustainability area. Ongoing work is under way to implement this in 2022.
- Addition of six new Councilors, that will enhance our cultural and innovation capabilities as well as reinforce our other core areas of climate change, clean energy and coastal conservancy.
- Hiring a Chilean Designer to develop in-house, compelling content to promote the CCC with potential donors, and communicate clearly and appealingly the results of our work.
- Continued financial support from the Ministry of Foreign Affairs of Chile, the Packard Foundation, Marisla Foundation, councilors, among other friends from the private and public sectors of Chile and California.
- Ongoing deliberations by the Financial Sustainability and the Strategic Sustainability Committees and the Board of Directors, to address key challenges and enable Staff to explore new arrangements that if successful, will increase the financial resources of the CCC several-fold. This has included the exploration of new alliances, new sources of funds, and areas of activity, that will broaden our presence and capabilities.

In 2022 we hope to continue growing the CCC by developing a broader, larger, and stronger financial base, expanding our core staff, reinforcing and expanding networks and institutional alliances, and increasing our presence and knowledge transfers via increased communications capabilities, and if Covid permits, in-person gatherings.

I am deeply thankful for all we are achieving, on a very limited budget, bare-bones Staff, and a volunteer Board and Councilors. Please join us to share successes in 2022 and beyond! There is still much to do!

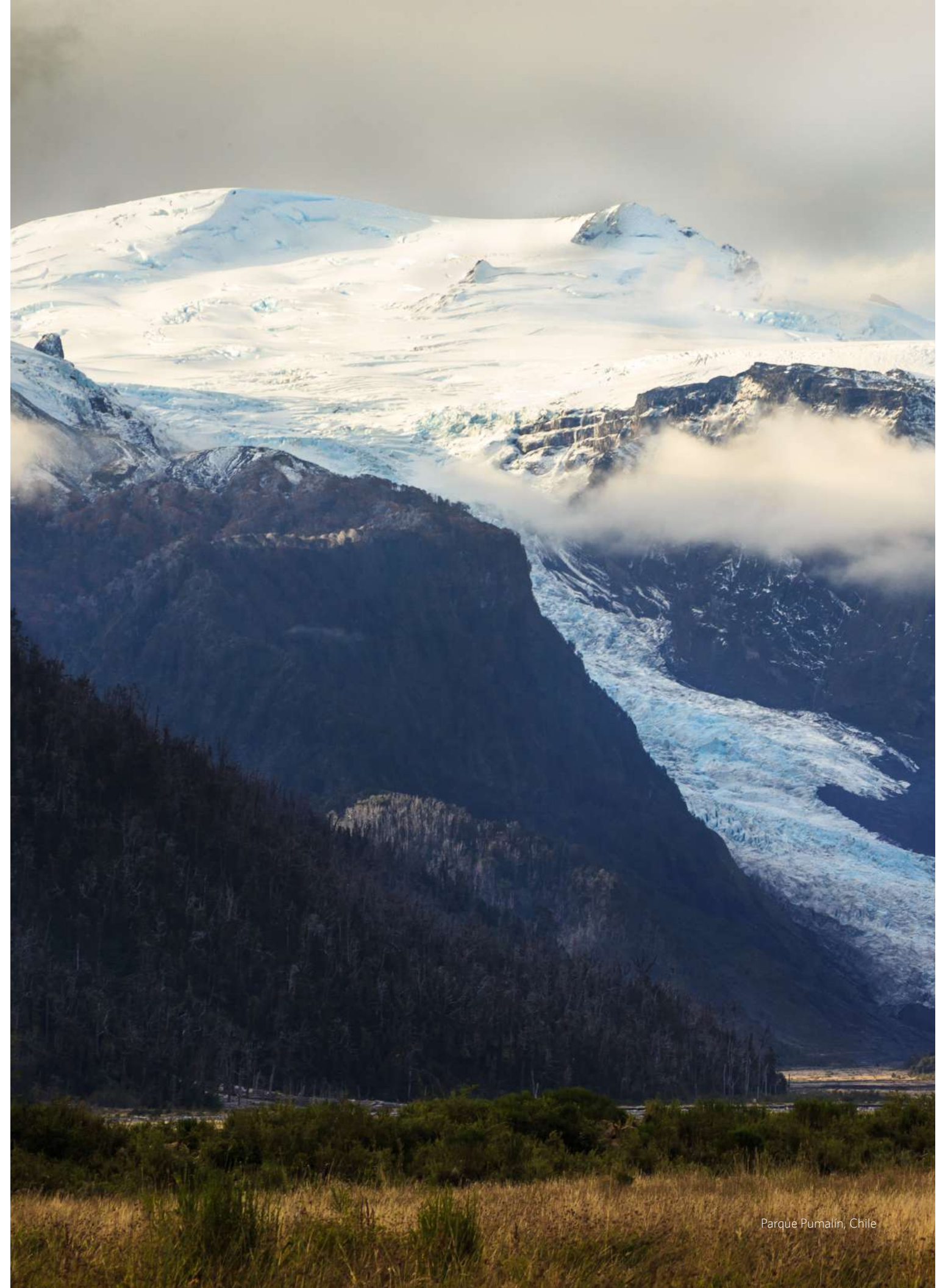

The Chile California Council incorporated as a 501 (c)(3) non-profit on the occasion of President Sebastián Piñera's visit to California, bringing together representatives from both public and private sectors.



2013

Chile and California renew an Agreement for Collaboration. Lt. Governor Gavin Newsom gives keynote address during CCC Annual Meeting highlighting the importance of technology in governance.



2015

President Bachelet and Governor Brown sign a historic joint declaration on climate change. The New UC Davis Chile Life Science Innovation Center launched.



2017

The CCC focuses on three areas: Natural Resources Management, State and Society, and Technology. It creates Chispa-Spark Funding: a lean platform to finance initial stages for mutually beneficial projects in Chile and California.



2019

The CCC focuses on actions that enable transformational processes related to tackling the climate crisis. The CCC participates and is involved in the organization of the COP25, showcasing California's coastal and Climate Change's policies and a Chilean scientific coalition studying climate effects along Chile's coastlines.



2021

The CCC focuses on in-depth structuring and consolidating programs, in addition to miscellaneous initiatives within its climate action driven agenda, particularly in the clean energy transition and coastal protection.



2008

Launch of the Chile California Plan. The Chile California Plan was created as a result of the Memorandum of Understanding between Chile's President Michelle Bachelet and California's then Governor Arnold Schwarzenegger.



2012

The CCC starts operations, appoints an Executive Director and organizes the Board into 5 committees: Environment, Innovation, Education, Trade, and Society.



2014

The CCC Board of Councilors approves a strategic plan for the next 4 years, emphasizing functional areas such as fundraising, communications, and finance.



2016

The CCC expands its influence in Chile and California by facilitating support and collaboration between CONAF-CALFIRE on wildfires prevention and control, and between Chile's Oficina Nacional de Emergencia (ONEMI) and California's Office of Emergency Services (CAL OES) on disaster management.



2018

The CCC holds first major conference on renewable resources, storage, and electric mobility.



2020

Humanity faces a pandemic and the Chile California Council adapts to the new normal by participating and leading webinars where relevant issues in today's world are discussed.

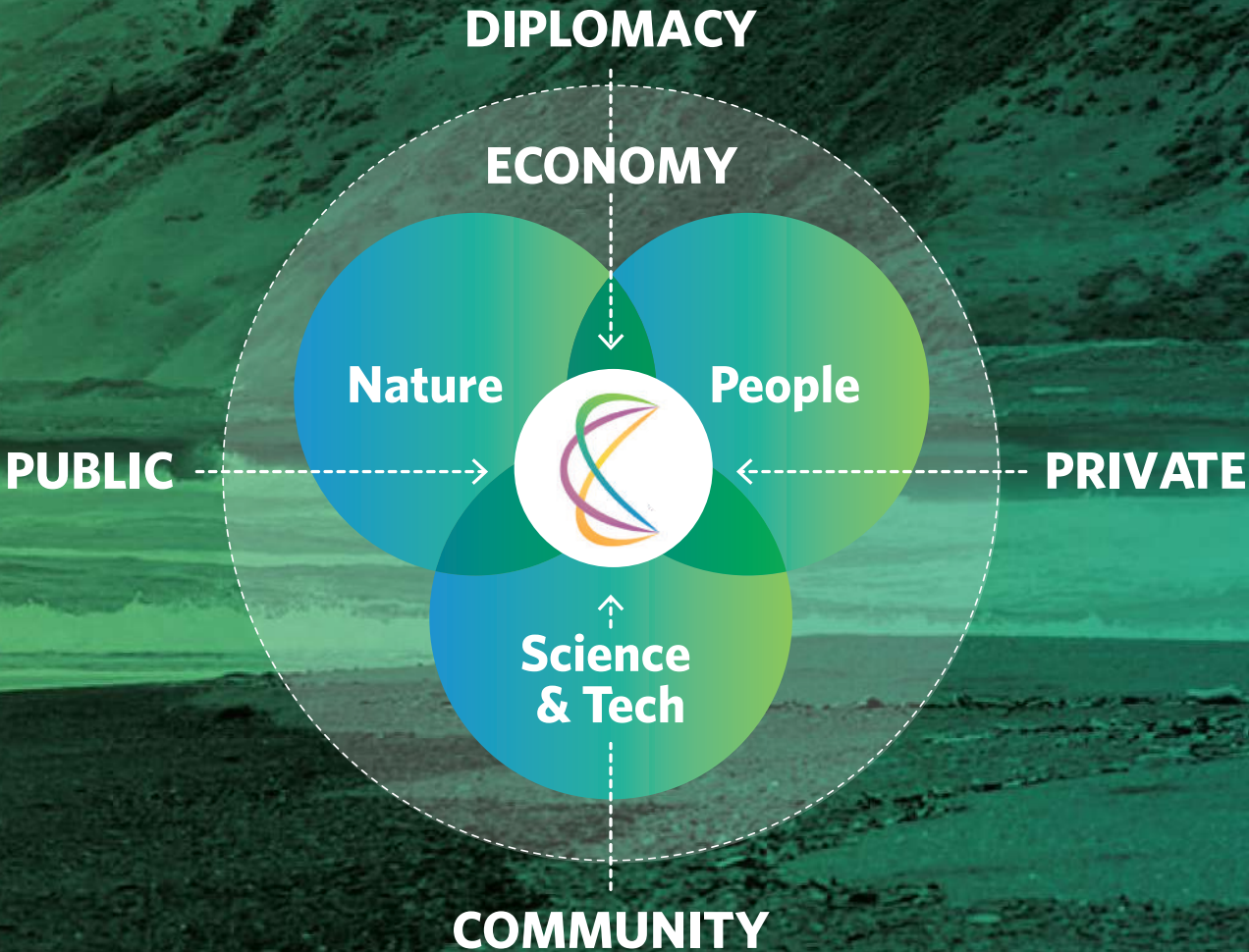


OUR HISTORY

REPRESENTATIVE BEFORE THE CCC LETTER



Dear Friends,

This is the third year I've had the honor to write this letter for the Annual Report of the Chile California Council. Along this period, the main driver has been to internally shape up the organization so it can reach its potential and remain resilient to external changes that have historically affected the CCC.

The first step to this road in 2019, was to determine the most proper agenda to build a purpose driven organization, that can bring continuous and applicable outcomes. In that regard – let's say this again – Chile and California are *trans-hemispheric twins*, which means that their natural dynamics and resources are so similar, that they share the most pressing challenges in the future.

As these territories are two of the six places in the world located in a Mediterranean Climate – the most affected by Climate Change – the CCC's work has been about *Climate Action* and how to help transfer knowledge to be more effective in that path. In that regard, and specially because of California's unquestionable leadership in addressing climate needs, the CCC has extra leverage connecting binational efforts towards reducing CO2 emissions.

We partnered with the governments of Chile and California to assist COP25 in Madrid, by showcasing two very important panels at the Chilean Pavilion. One was about the *Energy Transition*, where California presented how the State has managed to reduce the CO2 emissions from energy production, while still growing both GDP and population. The other panel we hosted was about *Coastal-Marine Management*, where we showcased the experiences of the Marine Life Protection Act (MLPA) that has created 124 Marine Protected Areas along California's coastline, and the Coastal Act that led to the creation of the California Coastal Commission.

After positioning the agenda of the CCC, in 2020, among systematizing our virtual gatherings and operations because of the pandemic, we also took steps to improve the governance of the organization to make it more agile and dynamic and better able to respond to the ecosystem in which it is immersed. We did this work supported by the generosity of the Organizational Effectiveness Program of the Packard Foundation, which allowed us to have a consultant to guide us through this process.

In 2021, we went deep into developing our programs that were designed to happen annually. We launched the *Chile-CA Energy Alliance* with the main players of the energy field of both places, in partnership with the Ministry of Energy of Chile and the California Energy Commission, to compare the strategies that both places are implementing to reach Carbon Neutrality – from the science, policy, technology, and investments points of view. Similarly, we designed and vastly socialized a Coastal-Marine Strategy for 2030, called *Enabling Conditions for Chile to Reach International Coastal-Marine Commitments*, which takes and adapts the fundamentals and procedures of the successful coastal-marine cases of California – the Coastal Act and MLPA – into Chile's own reality and idiosyncrasy.

These two programs, in addition to the now consolidated and going for its 5th edition *Chile California Conservation Exchange (CCCx)* founded by Councilors Ralph Benson and Tomás McKay; have provided a new structure and mechanism for the CCC to be ready to reach its full potential.

The CCC is operating as a Hub that develops Programs. Each program must be financially sustainable, and have its own goals, metrics, targets and management conditions. As a stand-alone, each program makes full sense and is developed with partners and sponsors, has its own branding under the CCC. Though each program has different products, when combined with those of the other programs, they create a holistic, interconnected agenda. This model serves to tackle the multi-layers of the challenges we face ahead through a systematic approach.

The main goal for 2022 is to connect the markets and economies to these programs. That's why we have been working to develop a program called *Chileformia Booster and Innovation Center (BIC)*, that can serve as a (1) soft-landing center for Start-ups looking to come to California, and (2) a R&D and ESG center for Chilean companies seeking new technologies, markets, and best practices to connect science and community, into consensus building processes that California has developed so well.

As all the other programs, the Chileformia BIC would operate sustainably as a stand-alone program to bring the Chilean entrepreneurial ecosystem to California, and vice versa. In addition, the BIC will engage with the other three CCC programs – Energy, Coastal-Marine and CCCx – to integrate innovation and market-based solutions to the challenges we are working on.

All said – the prospects for the CCC are promising and the organization is ready to scale-up. Both places concentrate amazing talents and VC culture, and it's important to build over that. The network of Councilors and friends at the San Francisco Bay Area, can still do much more to capture what's going on, for both Chile and California.

In these strange times the world still shakes around changes and evolution, the Chile California Council serves as a Network to keep knowledge and experience circulating at a higher rate. It's important to keep this transhemispheric *Chileformian* community together, that can enhance binational cooperation at levels we have not seen before.

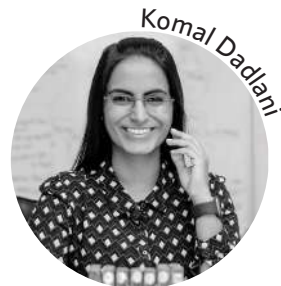

CHILE CALIFORNIA ENERGY ALLIANCE

In 2021, a Strategic Alliance was signed between the Chilean Ministry of Energy and the Chile-California Council, to collaborate; as Chile and California share many challenges and opportunities in the energy sector and their transition to more sustainable energy systems. With highly urbanized populations and an abundance of renewable energy resources in their respective regions, each offers the other lessons on best practices for increasing efficiency in the use of renewable resources and in distributing their potential throughout their respective territories.

In 2021, this Alliance held four working group sessions focused on the Transition process towards decarbonizing the Energy Systems of Chile and California. These sessions were sponsored by ACESOL, Generadoras de Chile, and the World Energy Council of Chile. Attendees included experts from the Chilean Ministry of Energy, the California Energy Commission, Academia, the private sector, trade associations, and non-profit organizations.

Executive Summaries of each session were developed, highlighting key issues, challenges, opportunities, policies and other interventions being carried out or considered by Chile and California to decarbonize their energy systems. In addition, the CCC carried out a Webinar Cycle to share with others key findings of each session. The four webinars are available on all the CCC's social media platforms. A Final Report is being prepared that will include the main conclusions of these sessions, and an actionable plan for future efforts in the medium and long term.

WORKING GROUP SESSIONS AND WEBINARS



Session 1: Energy Transition

The first session took place on May 19th, 2021, and focused on comparing the goals, key challenges, and opportunities that Chile and California face as they transition to more sustainable energy systems. The main highlights center around how much tangible impact can be obtained from increased collaboration and knowledge transfer; under a working plan designed to bring action and outcomes. Main outcomes included the emergence of concrete collaborative agendas among participants and identifying the most useful incentives, technologies and long-term investments required for the energy transition while tapping into the comparative and complementary experiences happening between Chile and California.

The Energy Transition Webinar was held on June 9th and was uploaded to the new CCC web platform, generating more than 208 views to date. The participants were Javiera Aldunate, Head of the International Relations Office of the Ministry of Energy of Chile; Allan Najum, DECYTI Councilor of the Ministry of Foreign Affairs; and Rafael Friedmann, Chair of the Chile California Council. Trinidad Castro, Executive Director of the World Energy Council Chile (WEC) moderated the Webinar. They discussed the energy transition and the follow-up meetings that would address the electrification decarbonization, transportation transition, and green Hydrogen transition.



Session 2: Electrification Transition

The second session took place on June 16th, 2021. The main highlights center around the potential exchanges between Chile and California regarding strategies, policies and incentives for the electrification decarbonization transition, and some of the most central technological and planning challenges, including pricing issues, electrification of more end-uses, upgrading transmission and storage infrastructure, and developing more flexible supply and demand of electricity.

The Electrification Transition Webinar was held on Wednesday, July 14th, and has more than 189 views to date. On this occasion, the participants were Nicolás Westenenk, Director of Environment and Climate Change at Generadoras de Chile; Aura Rearte, Director of Studies and Regulation at ACESOL; and Juan Pablo Carvallo, Principal Scientific Engineering Associate in the Electricity Markets and Policy department at the Lawrence Berkeley National Laboratory. Tatiana Molina, CCC Director, moderated the Webinar.



Session 3: Transportation Transition

The third session was held on July 21st, 2021. It focused on the strategy, incentives, and challenges that Chile and California have faced in order to promote and achieve zero-emission transportation. The main takeaways include the necessity of collaborative work among different stakeholders to break down technical, political, and social barriers to electromobility. Tax schemes, variable electricity rates, and incentives were a common topic in the three discussion groups to fund more projects that promote the use of zero-emission vehicles (ZEVs) and help to cover the gap of equity in disadvantaged communities.

The Transportation Transition Webinar of this session took place on September 10th. The participants were Daniela Soler, Head of the Efficient Transportation Unit, Ministry of Energy of Chile; Mark Wenzel, Manager, Office of Advanced Vehicle Infrastructure of the California Energy Commission; and Gabriel Guggisberg, Head E-Mobility, Agencia Sostenibilidad Energética. The conversation was moderated by Tatiana Molina, CCC Director. To date, it has more than 121 views on our digital platforms.



Session 4: Green Hydrogen Transition

The fourth and last session of 2021 was held on August 18th and focused on comparing green hydrogen transition goals, key challenges, and opportunities of Chile and California. The session's highlights were about the strategy, incentives and challenges that Chile and California face to promote a green hydrogen industry. The main takeaway is that strategies targeting both demand and supply need to be developed to create a hydrogen market. Infrastructure development, incentives, certifications, and research in hydrogen uses are all needed to develop the market.

The Webinar “Green Hydrogen Transition” took place on October 5th. The participants were Max Correa from the Ministry of Energy of Chile, Merrian Borgeson from the Natural Resources Defense Council (NRDC), Marcela Angulo from Universidad de Concepción and CCC Councilor; and was moderated by Tatiana Molina, CCC Director. It has more than 121 views to date in our digital platforms.

CHILE CALIFORNIA ENERGY EXPECTED 2022 ACTIVITIES

For 2022 the CCC will develop a second cycle of the Chile California Energy Alliance working group sessions that took place during 2021; with members of the Chilean Ministry of Energy, the California Energy Commission, and expert subject matter individuals selected by the Chile California Council. The foregoing added to an active agenda that will include - as in the year 2021 - visualization of the results through specific documents and via seminars, talks and webinars.

COASTAL MARINE STRATEGY 2030

The Chile California Council has developed a coastal marine strategy that seeks to build capacity and commitment to a science-based social process to achieve international climate goals by 2030 in Chile.

In 2021, the CCC prepared the internal document *“Enabling conditions for the implementation of successful coastal-marine policies in Chile”*, which shows Chile’s willingness to move forward with this strategy with the support and reference of California. This presentation was strongly socialized during the year with key actors - governments, NGOs, scientists, etc.

The document seeks to ensure that multidisciplinary visions are integrated into the analysis, so that it can represent coastal professionals in general, from the public and private sectors of Chile and California and for the implementation of collaborative actions that contribute to the objective of this area of action.

XL Congreso Ciencias del Mar

In the context of the XL Congreso Ciencias del Mar (XL Marine Science Congress), the Chile-California Council organized the “Citizen Science for Coastal-Marine Monitoring” panel, held on May 26th, on the potentials, opportunities and challenges of citizen science for the monitoring and sustainable management of coastal-marine resources and ecosystems in Chile.



Enabling conditions for effective Coastal-Marine protection policies in Chile

On May 28th, the last day of the XL Congreso Ciencias del Mar, the representative before the Chile California Council, Matías Alcalde, gave a keynote speech to present the Coastal Marine Strategy for Chile, using the favorable learning curves from the California experience.



Blue Water Summit

The second edition of the Blue Water Summit - an annual summit that was broadcast live- took place on June 7th. It celebrated the UN World Oceans Day. This summit delivered content for 9 hours by more than 50 thought leaders, ocean advocates, and other experts - including the CCC’s representative, Matías Alcalde.



World Oceans Day 2021

On World Oceans Day 2021, held on June 8th, Matías Alcalde presented the “Conditions for the implementation of effective coastal policies in Chile, using favorable learning curves from California”. The activity was organized by American Corner UACH, and American Corner UMAG.



Coastal Zone Canada Conference 2021

The Coastal Zone Canada Conference theme, held on June 14th, was “Inuit Qaujimajatuqangit: Planning and Preparing for the Future.” In this instance, on behalf of the CCC, Matías Alcalde and Juan Silva presented “Implementing Successful Coastal-Marine Policies in Chile: A Blueprint for Science-Based Participatory Design, Implementation, Governance and Monitoring of the Coastal Zone Using Favorable Learning curves from California.”



ANID Center’s Seminar Series in the Decade of the Oceans

The third day of the ANID-SHOA series of seminars, “Coastal zones and adaptation to climate change”, was held on June 22th within the framework of the Decade of the Oceans. The Representative before the CCC, Matías Alcalde, participated and presented the “Enabling conditions for the implementation of successful coastal-marine policies in Chile”.



UN Ocean Decade Conference

The Chile-California Council organized one of the satellite activities of the *Ocean Decade Laboratory: An Inspiring and Engaging Ocean*, where various experts shared valuable information about the ocean and its sustainable development. In this context, the CCC held on July 7th, the Webinar “Enabling Coastal Marine Strategies to Reach International Commitments”.



Coastal Governance: Where are we going?

This meeting organized by Nérida, brought together leaders of the Chilean coastline to discuss the challenges and opportunities concerning the sustainable development of the Chilean coastal zone and its communities. This meeting took place on August 30th. Its’ objective was to discuss different views on the current governance of the Chilean coastal zone, the need for a new ordering, and how the institutional framework should help address the social and environmental challenges of the territories.



Govern... what? Governance: Participatory solutions... without simulations

Matías Alcalde, participated with Liliana Gutierrez in the Webinar “Governance: participatory solutions...without simulations” of the BIOCITIS project, held on October 6th. In this meeting, relevant issues on governance for sustainable territories and cities were discussed, in a conversation moderated by Guadalupe Wallace, Coordinator of the BIOCITIS project.



Workshop on Climate, Biodiversity and Marine Protection in Latin America

The Chile California Council was invited to organize and participate in the “Workshop on Climate, Biodiversity and Marine Protection in Latin America”. It was co-organized by the International Alliance to Combat Ocean Acidification, The Ocean Foundation, The Chile California Council, The Latin America Ocean Acidification Network and The International Partnership on MPAs, Biodiversity and Climate Change.

The Workshop took place on October 21st. It was an initiative in advance of COP26, in order to provide an overview of the high-level commitments for ocean climate action made in Latin America, updates of regional science and monitoring networks documenting ocean change in the region, and policy frameworks and integrated management strategies related to coastal and marine protection, among other topics. The representative before the CCC, Matías Alcalde, was invited to speak on “Enabling Coastal Marine Strategies to Reach International Commitments”.

COASTAL MARINE STRATEGY EXPECTED 2022 ACTIVITIES:

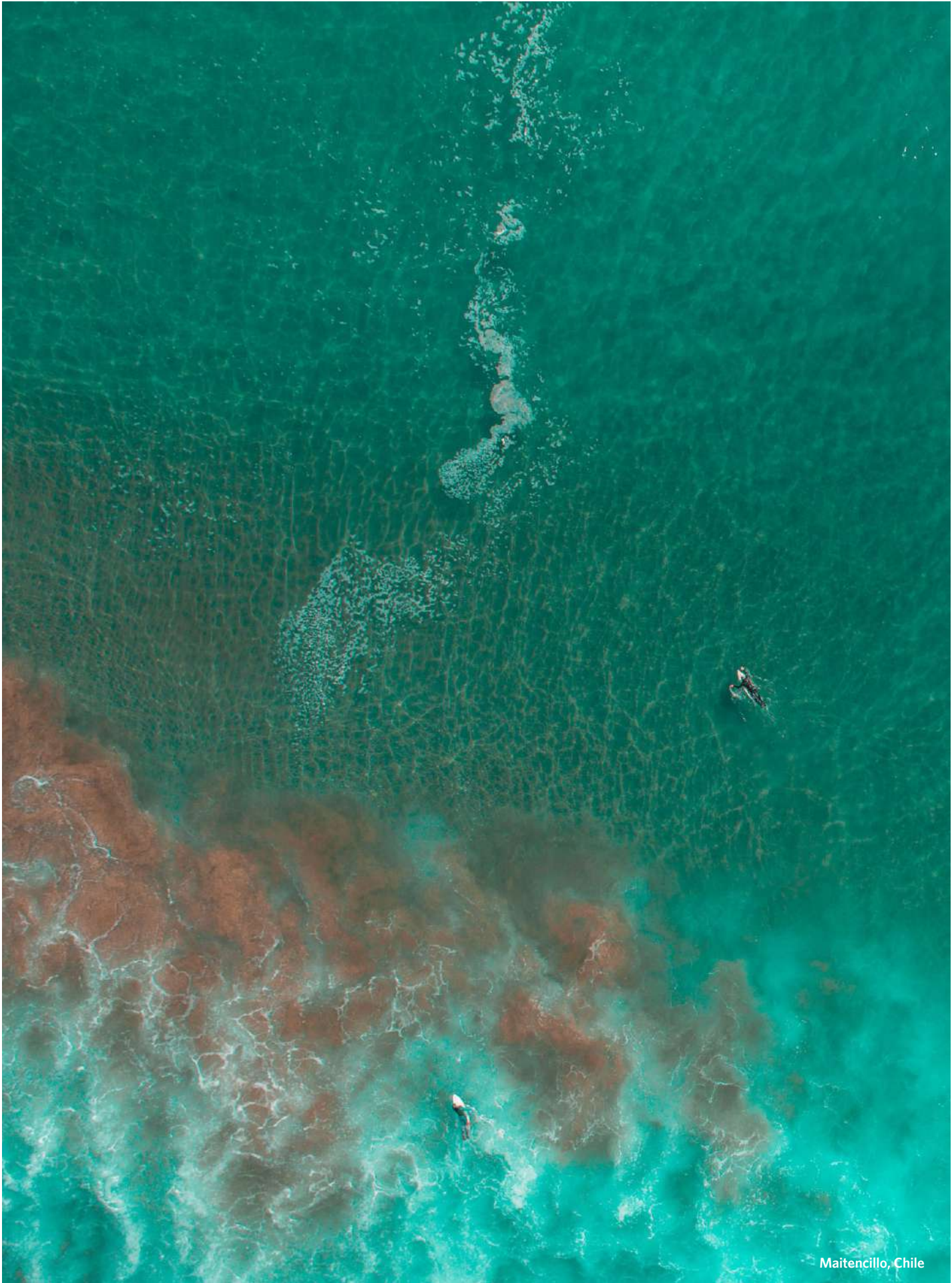
During 2022, we will continue to deepen the Coastal Marine Strategy by developing capacity building programs and science integration. We are working to develop a multidisciplinary assessment to determine the value of protecting Chile's coastline together with a Citizen Science Program for Protected Coastal-Marine Areas in Chile. It is expected that that this will include the holding of multidisciplinary integration workshops and the continuation of the strategy's socialization work.

CHILE CALIFORNIA CONSERVATION EXCHANGE THE PUBLIC TRUST DOCTRINE

Through the CCCx - a program nested in the CCC and managed by Councilors Ralph Benson and Tomas McKay -, the Chile California Council has sponsored annual conferences in California in 2017, 2018 and 2019. These meetings have been attended by academics and professionals from the public and private sectors working on conservation issues of Chile and California. Due to COVID-19, it was impossible to bring people together in person in 2020-2021. This led the CCCx to gather a group of legal and natural resources experts in California and Chile to prepare a document “Protección de la Naturaleza y una Nueva Constitución Para Chile: Lecciones de la Doctrina del Public Trust” (Protection of Nature and a New Constitution for Chile: Lessons from the Public Trust Doctrine) that explores the relevance of the Common Law Public Trust Doctrine to the conservation of nature in Chile.

The document “Protección de la Naturaleza y una Nueva Constitución Para Chile: Lecciones de la Doctrina del Public Trust” was sponsored by the Chile California Conservation Exchange and the Diego Portales University, through the Context Project. The purpose of this report is to examine the lessons that the Chilean constitutional process can draw from the public trust doctrine in the United States for a more robust constitutional protection of nature. As a response to a profound political and social crisis, Chile has begun a process of drafting a New Constitution that has generated high expectations in the population, especially in terms of environmental protection. This report shows that the current constitution has deficiencies in this area that have not allowed a sufficiently robust protection of the environment and natural resources. In this context, the report explores the lessons of the Public Trust Doctrine that can provide favorable lessons to improve some aspects of the

current constitution in this matter. This doctrine states that certain elements of nature are subject to a special obligation for the government to manage and protect them for the benefit of the public. The report describes the central characteristics of this doctrine in the United States, its jurisprudential evolution and how it has been included in constitutional texts in states such as Hawaii and Pennsylvania. The report is aware of the institutional and cultural differences between the United States and Chile, and therefore critically compares the public trust doctrine with similar doctrines in Chile, such as the public domain (dominio público) and the social function of property (función social de la propiedad). The implementation challenges that a clause inspired by the Public Trust Doctrine would have in Chile are also analyzed, particularly in terms of the functions of the legislature, the administration and the courts.

CCCX EXPECTED 2022 ACTIVITIES:

CCC'S ANNUAL MEETING

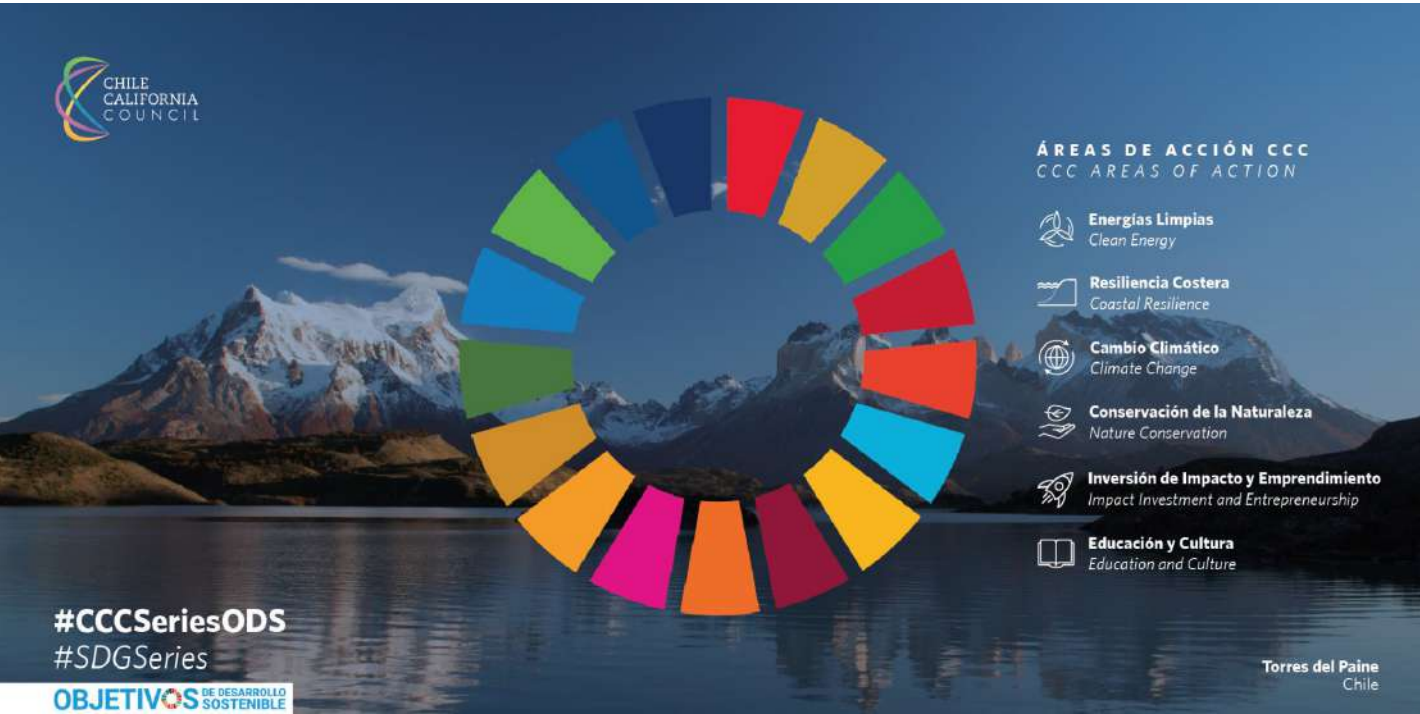
